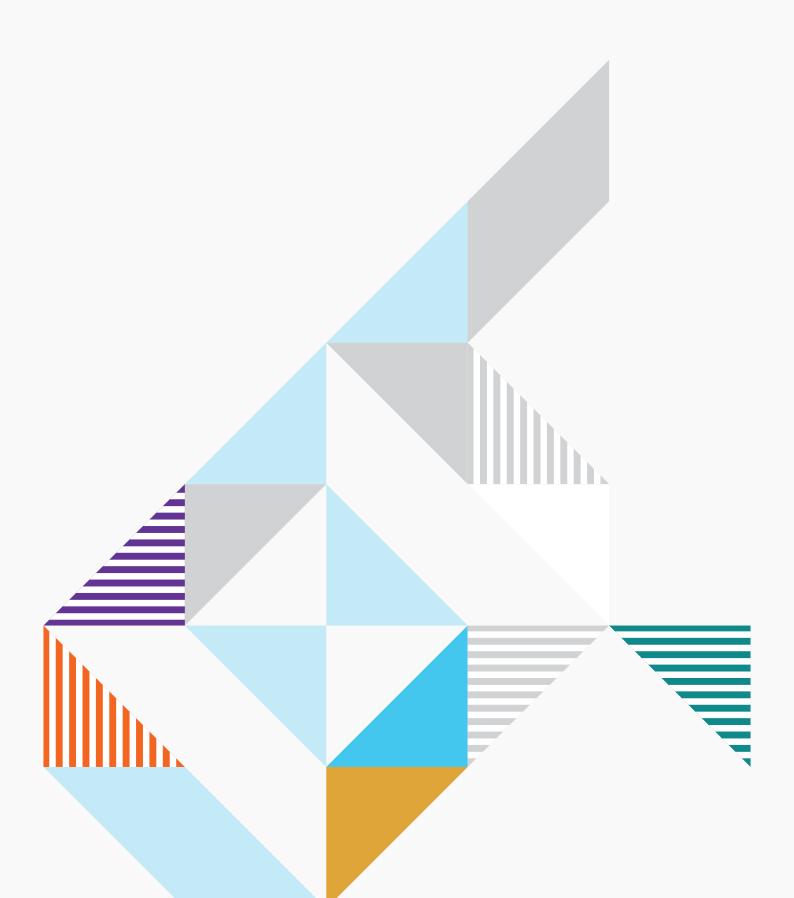

### **About Academic Advising**

At Hamad Bin Khalifa University (HBKU), academic advising is a vital component of your educational journey. Our goal is to support you in making informed decisions that align with your personal interests, academic goals, and career aspirations.

Effective advising can enhance your academic experience, increase your chances of timely graduation, and ensure you make decisions that reflect our aspirations. It also provides a support system to navigate challenges and maximize your opportunities during your time at HBKU.

### Who is Your Academic Advisor?

It is advised that you schedule at least two appointments each semester with your academic advisor, particularly if you require referrals to campus resources. Students should also note the importance of booking an appointment with their academic advisor at least two weeks before registration periods. Alongside full-time academic advisors, faculty members within your department or program are also available to assist with mentoring. They may also provide career advice regarding your specialization.

### What to Expect from Your Academic Advisor?

- Your advisor will review your progress, offer guidance on course selection, discuss your academic goals, and answer any questions you have. Nonetheless, it is ultimately your responsibility to keep track of your progress. You can view detailed information about your degree requirements, completed courses, remaining credits, and current academic standing through the student portal.
- Your advisor will work with you to develop a semester-by-semester plan that aligns with your graduation timeline. Consider prerequisites, elective choices, and opportunities for internships. Please meet with your academic advisor before attempting to register for courses.
- Your academic advisor will discuss with you the academic policies and guidelines that affect your graduation, such as Drop/Add Deadlines, Grading and Academic Standing, Attendance, and Leave of Absence. Make sure to pay attention to academic policies and guidelines. Ensure you understand the credit hours needed, core curriculum, major requirements, and GPA standards. Regularly review your progress to stay on track.

### **How to Schedule and Prepare for Advising Appointments?**

- 1. Reach out to your academic advisor and schedule an appointment by email at: shaghamed@hbku.edu.qa
- 2. Attend scheduled advising appointments: Ensure you arrive on time, prepared.
- **3.** Prepare for advising sessions: Review your academic progress and come with questions or topics you'd like to discuss.
- **4.** Ensure your class registration is in line with your study plan by staying up to date with registration deadlines and degree requirements.
- **5.** Reflect on our academic and career objectives: To make the most of your time with your advisor and steer the conversation effectively, consider questions like:
  - "Which courses do I enjoy most?"
  - "What are my goals after graduation?"
  - "Where do I see myself working?"
  - ▶ "What challenges do I need to overcome to graduate on time with excellent grades?"
- **6.** Communicate proactively: Notify your advisor of any changes or challenges to your academic plans or personal circumstances that may affect your studies.
- 7. Follow through: Evaluate how you can implement the guidance and recommendations provided during advising sessions.

# **HBKU Library**

HBKU Library welcomes users to both of its branches: the Main Library and the Engineering Library, with expansive reading areas that provide a calm ambiance for visitors to focus, study, and work.

### **Print and Electronic Resources**

More than 50,000 print books are displayed in both libraries and can be borrowed by students for up to 10 days each, up to a maximum of 5 books at the same time. The borrowing period can be extended online twice via the online <u>library account</u>.

# **University Writing Center (UWrite)**

### **Graduate Support**

The University Writing Center (UWrite) provides English and Arabic academic writing support services to HBKU students. The center offers the following core services:

- Synchronous online: Students use the booking service platform or Webex to work on a paper collaboratively with the writing specialist concurrently.
- ▶ E-tutoring: This option allows students to attach a paper to be reviewed by a writing specialist during the booked consultation period.

### 2. Workshops and in-class support sessions

UWrite specialists conduct workshops and in-class sessions on various academic writing topics throughout the academic year.

### 3. Digital resources

A comprehensive collection of online self-help resources is available and regularly updated on the <u>UWrite English</u> and <u>Arabic</u> LibGuide pages.

### **Undergraduate Support**

Writing, communication, and multimedia support services are available to all undergraduate HBKU students:

### 1. Individual or group consultations:

Consultations can be pre-booked via <u>online booking</u> or walk-ins. Students are required to <u>register for an account</u> to book sessions online.

The consultation sessions are available in two modes:

**Face-to-face:** Sessions are conducted in Suite 310, Manufactury. **Synchronous online sessions:** Sessions are conducted via Microsoft Teams or Zoom. Once sessions are booked, students will receive the link to the platform.

### 2. In-class workshops:

These workshops are an integral part of the Engineering curriculum and are facilitated in collaboration with faculty.

### 3. Digital resources:

The collection of online resources includes handouts and tips that complement students' skills in writing, communication, and multimedia.

### **Student Success Services for Undergraduate Students**

The Student Success Services provides academic support to help undergraduate students achieve their educational goals. It includes:

1. Peer Tutoring: Students can book free one-to-one or group appointments for chemistry, physics, math, and engineering courses. Those sessions are tailored based on students' needs and focus on complex concepts, problem-solving, chapter reviews, study skills, and course confidence. #### How to access:

- New users can create an account at any time and then book appointments through the online schedule.
- All our sessions are conducted face-to-face in Suite 310, Manufactury, from 09:00 to 17:00 except on weekends.
- Online appointments can be arranged only if necessary. Walk-ins are welcome.
- 2. Supplemental Instruction (SI): Students can attend weekly interactive learning sessions for selected challenging courses. These group-based sessions help to reinforce the challenging course concepts, practice problems, and apply effective learning strategies. SI leaders coordinate these voluntary sessions at the beginning of the semester. All the sessions are conducted in the Manufactury building.
- 3. Academic Coaching is available to help students build effective study habits, set goals, and overcome challenges like procrastination or test taking. Students can schedule their coaching sessions to boost motivation, confidence, accountability, and long-term academic success.

- ▶ Short training courses and workshops (in-person, hybrid, and online): These are offered by industry leaders and subject matter experts in three focused areas: leadership and management, emerging technology, and innovation and entrepreneurship.
- International certification: Through partnerships with organizations like the Institute of Leadership and Management (ILM), the Association of Project Management (APM), and Six Sigma, the program offers globally recognized certifications, beginning with an endorsed leadership program and expanding to certifications in other high-demand fields.
- ▶ Short industry-led programs: They are organized in collaboration with the global and local engineering and government sectors to expose students to practical engineering scenarios, enhancing the students' engineering knowledge, professional network, and career opportunities.
- Competitions and hackathons: These help students inculcate an innovation and entrepreneurial mindset, giving them the tools to excel in interdisciplinary team settings.
- Participation recognition: Students' involvement in enrichment activities is documented in a formal student involvement record and high-impact experience hours, with outstanding contributors eligible for annual awards, enhancing their academic and career portfolios.

- 2. HBKU Innovation Funds Office: A dynamic pillar dedicated to managing and distributing funds and fostering a collaborative, multidisciplinary, and locally relevant innovation environment through initiatives such as:
  - Student Innovation Fund (SIF)
  - ▶ The Innovative Business Discovery and Acceleration Fund (IBDA)
  - ▶ Industrial Innovation Fund (IIF)
  - Social Innovation Fund (SOCIF)

HBKU students, both undergraduate and graduate, may benefit from the Student Innovation Fund (SIF), which supports the development of early-stage entrepreneurial ideas, either individually or as part of a team. Students who have launched startups may also be eligible for IBDA, which supports HBKU-led companies in their early-stage development. Projects supported by these funds often continue their development at the HBKU Innovation Center. Some evolve into startups, while others are showcased at prestigious innovation platforms. For example, Dr. Muhammad Fazlurrahman Syarif, a PhD graduate from the College of Islamic Studies and a Cycle 6 SIF awardee, was awarded second place in the Rising Innovators Award by the Qatar Research, Development, and Innovation (QRDI) Council at the 2025 Web Summit.

3. Intellectual Property Office (IPO): As the gateway to research, development, and innovation activities, the Intellectual Property Office (IPO) plays a crucial coordinating role at the core of HBKU's dynamic innovation and entrepreneurship ecosystem. Our office is dedicated to identifying and protecting intellectual property (IP) developed at Hamad Bin Khalifa University. By safeguarding these valuable assets, we ensure that groundbreaking ideas and technologies are securely preserved. The IP Office offers a comprehensive suite of services designed to support HBKU students, staff, faculty, and researchers in navigating the complex landscape of IP protection.

Our role is to ensure that students are informed and empowered to identify, protect, and manage their IP in line with HBKU's IP Policy and broader commitment to research impact and knowledge sharing.

- Explaining students' rights under the HBKU IP Policy in the context of individual research, group projects, and external collaborations.
- Offering guidance on disclosing inventions or creative work developed as part of university research.
- Providing advice on how IP can be protected, including through patents, copyrights, and trademarks, where appropriate.
- > Supporting students in understanding IP in the context of commercialization.
- Coordinating with faculty and project supervisors to ensure fair recognition and protection of student contributions.
- Running workshops and guest lectures on IP fundamentals, student rights, and real-world applications of IP.

Our services are available to all HBKU students and are designed to equip you with the knowledge and support you need to confidently navigate the world of intellectual property.

### Student Life Awards

The Student Life Awards are a set of non-academic awards held annually. The awards aim to recognize exceptional students who have made noteworthy contributions to the university outside of academia. Awardees are evaluated for their informal learning through participation in co-curricular activities, involvement in the arts, community service, community engagement, student leadership, competitions (non-sports), and sports accomplishments.

### **Student Development Program**

Students earn recognition by progressing through three self-paced tiers of involvement, with achievements tracked through the Musharaka platform. ### **Three Minute Thesis Competition**

Three Minute Thesis (3MT) is a contest open to doctoral students, launched by the University of Queensland, Australia, and brought to HBKU by Student Affairs. The 3MT competition requires competitors to deliver a succinct overview of their thesis to a non-specialist audience in three minutes or less. Competitors are required to present their research using a single static slide. A panel of three judges assess competitors based on comprehension, content, engagement, and communication.

Abuse of the student conduct, disciplinary, and/or legal processes, including, but not limited to investigations, conferences, and appeals. Prohibited behavior includes, but is not limited to:

- Failure to obey the notice from HBKU staff to appear for a meeting or conference as part of an official university disciplinary process.
- Falsification, distortion, or misrepresentation of information.
- Disruption or interference with the orderly conduct of an investigation, conference, or appeal process.
- Intentionally initiating false reports.
- Attempting to discourage an individual's proper participation in, or use of, a student conduct, disciplinary, or legal process.
- Attempting to influence the impartiality of a staff member prior to, during, and/or after the student conduct, disciplinary, or legal process.
- Verbal or physical intimidation, and/or retaliation of any party to the Student Conduct proceeding prior to, during, and/or afterwards.
- Committing a violation of HBKU rules while serving a conduct probation, conduct review, or deferred suspension status, or failing to meet deadlines imposed in accordance with the university.
- ▶ Failure to abide by the terms of HBKU-administered sanctions.
- Influencing or attempting to influence another person to commit abuse of the student conduct system.

### **Academic Violation**

Academic violation is any action intended to give an unfair academic advantage to the student.

#### **Alcohol**

Alcohol use, possession, manufacturing, or distribution of alcoholic beverages is prohibited on HBKU premises and at university-sponsored events. In addition, the use, possession, or distribution of alcoholic beverages while driving or riding in or on a vehicle on Qatar Foundation premises is prohibited. Alcoholic beverages may not, under any circumstances, be used by, possessed by, or distributed to any person. Individuals may not be in a state of public intoxication or drunkenness. Individuals may not operate a motor vehicle or any other form of transportation while intoxicated or while under the influence of alcohol.

### **Animal Cruelty**

Intentionally, knowingly or recklessly torturing or in a cruel manner killing or causing serious bodily injury to an animal, failing to provide necessary food, water or care for an animal in the person's custody, abandoning unreasonably an animal in the person's custody, transporting or confining an animal in a cruel manner, causing bodily injury to any animal without the owner's consent, causing one animal to fight with another animal, or seriously overworking an animal. Intentionally, knowingly, or recklessly attacking, injuring, or killing an assistance animal or inciting another to attack, injure, or kill an assistance animal.

This policy is not intended to prohibit:

- Killing or injuring an animal within the scope of a person's employment or furthering the goals of a legitimate educational curriculum as designed and approved by the university.
- Killing or injuring an animal when the actor had a reasonable fear of bodily injury to self or another person by that animal.

### **Bias-Related Violations**

Student conduct motivated by prejudice toward a person or group because of factors such as race, religion, ethnicity, disability, national origin, age, or gender may result in an enhanced sanction.

### **Breaching Safety or Security**

This includes but is not limited to: Unauthorized access to university facilities; unauthorized entry into or use of university premises; intentionally damaging door locks; unauthorized possession of university keys or access cards; duplicating university keys or access cards; propping open of exterior residence hall or other campus building doors; tampering with fire safety equipment such as fire extinguishers, smoke detectors, alarm pull stations, gas detectors, or emergency exits; and/or authorized entry into another person's or entity's residence vehicle, or business.

### **Bullying and Cyber-bullying**

Conduct that threatens, intimidates, or is intended to intimidate, or cause harm to another person. This includes the use of electronic/social media.

### **Bias-Related Violations**

Student conduct motivated by prejudice toward a person or group because of factors such as race, religion, ethnicity, disability, national origin, age, or gender may result in an enhanced sanction.

### **Complicity**

Attempting, aiding, abetting, conspiring, hiring, or being an accessory to any act prohibited by this code shall be considered to the same extent as completed violations.

#### **Damage**

Behavior that destroys, damages, or litters any property of Qatar Foundation, of a Qatar Foundation community member, or of another person, on or off campus, is prohibited under this rule.

#### **Dishonesty**

Acts of dishonesty, including but not limited to the following: forgery, unauthorized alteration or misuse of any document, record, or instrument of identification. Also includes withholding material information from the university, misrepresenting the truth before a hearing of the university, and making false statements to any university official.

## **Disorderly Conduct**

Public behavior that is disruptive, lewd, or indecent; breach of peace; or aiding, or procuring another person to breach the peace at functions sponsored by the university or participated in by members of the university community.

#### **Disruptive Activity**

Disruption of obstruction of teaching, research, administration, or other University activities (including public-service functions on or off campus) or of other authorized non-university activities when conduct occurs on university premises. Such activities may include, but are not limited to:

- Leading or inciting others to disrupt scheduled and/or normal activities on university premises.
- Classroom behavior that seriously interferes with either (a) the faculty member's ability to conduct the class or (b) the ability of other students to profit from the instructional program.
- Any behavior in class or out of class, which for any reason interferes with the class work of others, involves disorder, or otherwise disrupts the regular and essential operation of the university.

#### **Drugs**

The act of using, possessing, being under the influence of, manufacturing, or distributing illegal drugs, or illegally obtained/possessed controlled substances, is prohibited. Abusing legally obtained drugs by failing to take the drug as directed. Except as expressly permitted by law, use, possession, manufacturing, distribution, or being a party thereto of marijuana, heroin, narcotics, or other controlled and/or prescribed substance and/or drug paraphernalia and/or dangerous drug is also prohibited. Individuals may not operate a motor vehicle or another form of transportation while under the influence of drugs or while intoxicated

#### **Evading**

Intentionally fleeing from a university official or law enforcement officer when the person knows or reasonably should have known the university official or law enforcement officer is attempting to confront, arrest, or detain.

#### **Failure to Comply**

Failure to comply with proper and lawful direction of any university official or law enforcement office.

#### **Failure to Present Identification**

Failure to provide identification upon the request of a university official.

#### **False Reporting**

Intentionally making or causing to be made a false report, warning, threat of fire, explosion, or other emergency concerning the university and university-sponsored activities.

#### Harassment

Behavior that is severe, pervasive, or persistent to a degree that a reasonable person similarly situated would be prevented from accessing an educational opportunity or benefit. This behavior includes, but is not limited to, verbal abuse, threats, intimidation, and coercion. In addition, harassment may be conducted by a variety of mediums, including but not limited to physical, verbal, graphic, written, or electronic.

#### **Misuse of Computing Resources**

Failure to comply with university regulations and policies, license agreements, and contracts governing network, software, and hardware use; abuse of communal resources, use of computer resources for unauthorized commercial purposes or personal gain; failure to protect passwords or use of student account; breach of computer security, harmful access, or invasion of privacy. Misuse and/or other abuse of computer facilities and resources, including, but not limited to:

- Use of another individual's identification and/or password.
- Use of computing facilities and resources to send obscene or threatening messages.
- Use of computing facilities and resources in violation of copyright laws.

### **Off-Campus Conduct**

When a student is alleged to have violated the Student Code of Conduct by an offense committed off of university premises, the university may investigate and adjudicate. The university may take action in situations occurring off university premises involving student conduct that may cause harm to another, result in damage to property, or otherwise adversely affect the university community and its standing in the community. This action may be taken for either affiliated or non-affiliated activities. If the Vice President for Student Affairs determines that the offense affects the university as stated above, then the Student Affairs Office shall hold an administrative hearing to consider whether the offense is of such nature as set out above, whether or not the student committed the offense, and take appropriate action. The action of the university administrative hearing officer shall be made independent of any off-campus authority.

#### **Physical Abuse**

Any attempt to cause injury or inflict pain, or causing injury or inflicting pain. Also causing physical contact with another when the person knows or should reasonably believe that the other will regard the contact as offensive or provocative. It is not a defense that the person, group, or organization against whom the physical abuse was directed consented to or acquiesced to the physical abuse.

The physical abuse rule is not intended to prohibit the following conduct:

- Customary public athletic events, contests, or competitions that are sponsored by the university or the organized and supervised practices associated with such events.
- Any activity or conduct that furthers the goals of a legitimate educational curriculum, a legitimate extracurricular program, or a legitimate military training program, as defined and approved by the university.

#### **Reckless Driving**

Driving in a manner that recklessly endangers the health and/or safety of oneself or others.

#### Retaliation

Any adverse action taken against a person for making a good faith report of a violation of Qatar Foundation policies, university rules, student rules, and/or the law, or for participating in any proceeding related to the investigation or resolution of such report. Retaliation includes threatening, intimidating, harassing, coercing, or any other conduct that would discourage a reasonable person from engaging in activity protected under this policy. Retaliation may be present even where there is a decision of "unsubstantiated," "insufficient information to substantiate," "not responsible," and/or "not guilty" on the allegations. Retaliation does not include good-faith actions lawfully pursued in response to a report. Violation of an interim, remedial, or protective measure will be considered retaliation.

#### **Sexual Contact**

Attempting or making sexual contact, including but not limited to, inappropriate touching, or in circumstances where the person is physically, mentally or legally unable to give consent when the behavior is not so severe, pervasive, or persistent to create a work, educational, or campus living environment that a reasonable person would consider intimidating, abusive, offensive, or sexually exploitative. Sex-based behaviors include those that are severe, persistent, or pervasive to create a work, education, or campus living environment that a reasonable person would consider intimidating, abusive, offensive, or sexually exploitative; sexual assault, or sexual harassment.

#### Theft

Unauthorized removal or stealing and/or attempted removal or stealing of property of a member of the university community or other personal or public property, on or off campus. This includes knowingly possessing such stolen property. This also includes theft of services and/or misuse of another's property, including, but not limited to, unauthorized use of another's property, unauthorized selling of subsidized tickets, and use of a forged parking permit.

#### **Traffic Obstruction**

Obstruction of the free flow of pedestrian or vehicular traffic on university premises or at universitysponsored or supervised activities.

#### **Unauthorized Recording**

Any unauthorized use of electronic or other devices to make an audio, video, still frame, or photographic record of any persons without their prior knowledge, or without their effective consent when the person or persons being recorded have a reasonable expectation of privacy and/or such recording is likely to cause injury or distress. This includes, but is not limited to, taking pictures of another person in a gym, locker room, or restroom, or recording administrative meetings with university officials. If a recording is made that captures a violation of the Student Rules or law, the Student Conduct Administrator may elect not to enforce this section of the Student Rules against the student making the recording.

## **Unauthorized Representation**

Any act that violates the laws of Qatar is a violation of this code.

#### **Violation of Published University or Qatar Foundation Rules**

Violation of any university or System policy, rule, or regulation, including, but not limited to, university Housing contracts and rules, university motor vehicle rules, rules relating to the use of student identification cards, entry, smoke and tobacco-free campus rule, and use of university facilities and dining hall conduct.

#### **Violations of Law and University Discipline**

The focus of inquiry in student conduct proceedings shall be the determination of whether a violation of university rules occurred. Student conduct proceedings shall be informal in nature and need not comply with the formal processes associated with the criminal and civil courts, nor shall deviations from prescribed process necessarily invalidate a decision or proceeding unless significant prejudice to the student or university may result.

Standards outlined by the university for students may be higher than those standards set for the general population. As each person is subject to multiple layers of expectations through the local laws of the State of Qatar or policies of Qatar Foundation, students are further expected to maintain a higher standard of behavior as members of the HBKU community. Students failing to adhere to those standards may be subject to a university conduct process in addition to civil or criminal litigation should the behavior also be a potential violation of the law. The attempted analogy of student discipline to criminal proceedings against adults and juveniles is not sound.

Students may be charged with conduct that potentially violates both the criminal law and this Student Conduct Code (that is, if both possible violations result from the same factual situation) without regard to the pendency of civil or criminal litigation in court or criminal arrest and prosecution. Proceedings under this Student Conduct Code may be carried out prior to, simultaneously with, or following civil or criminal proceedings off campus at the discretion of the Vice President for Student Affairs or designee.

Determinations made or sanctions imposed under this Student Conduct Code shall not be subject to change because criminal charges were dismissed, reduced, or resolved in favor of or against the criminal law defendant.

When a student is charged by federal, state, or local authorities with a violation of law, the university will not request or agree to special consideration for that individual because of that individual's status as a student. If the alleged offense is also being processed under the Student Conduct Code, the university may advise off-campus authorities of the existence of the Student Conduct Code and of how matters are typically handled within the university community. The university will attempt to cooperate with law enforcement and other agencies in the enforcement of criminal law on campus.

## **Weapons and Explosives**

Illegal or unauthorized use, possession, or storage of fireworks or explosives, other weapons, or dangerous chemicals on university premises or at any university-sponsored activity is prohibited. In addition, use of any such item, even if legally possessed, in a manner that harms, threatens, or causes fear to others is prohibited. The term weapon is defined as any object or substance designed or used to inflict a wound, to cause or threaten injury, or to incapacitate. Weapons may include, but are not limited to, all firearms, pellet guns, tasers, stun guns, slingshots, martial arts devices, switchblade knives, and clubs.

## **Student Conduct Proceeding**

Any student whose conduct is the subject of a complaint by any member of the university community or who is alleged to have violated the Student Code of Conduct and/or any HBKU or Qatar Foundation regulations will be notified of the complaint or charge via email and/or in person by the Office of Student Affairs.

Once notified, a Student Conduct Administrator will investigate the facts and circumstances surrounding the complaint. The investigation may result in formal charges, an alternative dispute resolution (such as mediation or informal resolution), or the dismissal of the complaint.

#### **Investigation Process**

If a complaint is made against a student, they are considered the "respondent." The respondent will be notified via university email (or another appropriate address) about the reported allegation.

The Student Conduct Administrator will schedule a conference with the student to explain the conduct process and hear their version of the event in question. The student is expected to attend the meeting. If there is a scheduling conflict, the student may reschedule.

Failure to attend the meeting may be considered a violation of the Student Code of Conduct and could result in the process proceeding without the student's participation.

The following steps will take place:

- 1. The Student Conduct Administrator will meet with the student to explain the allegation.
- 2. The Student Conduct Administrator will outline the student conduct process, including the student's rights and responsibilities.
- 3. The Student Conduct Administrator will listen to any statement the student wishes to provide.
- **4.** If the Student Conduct Administrator determines there is sufficient cause to charge the student, the charges will be communicated in writing via university email. The charge letter may also indicate the more severe possible outcome of the conduct conference.
- **5.** If the student is charged with violating the Student Code of Conduct, they will have the opportunity to review their conduct file and may:
  - Accept responsibility at any point of the investigation, waive their right to an administrative hearing, and move directly to the sanctioning phase.
  - ▶ If they do not accept responsibility for the charge, they may proceed to an administrative hearing.
- **6.** The respondent will be given at least three university business days to prepare for the administrative hearing, unless they choose to waive their right in writing.

#### **Findings**

A finding of responsibility must be determined based on the preponderance of the evidence and cannot rely solely on the respondent's silence during the administrative hearing. If a respondent is found responsible for a violation, they have the option to accept or appeal against the findings and/or sanction, either fully or partially. A "responsible" finding will result in a sanction, while a "not responsible" finding will conclude the conduct process and close the case.

#### **Failure to Complete Sanctions**

Students are expected to comply with conduct sanctions within the timeframe specified by the Student Conduct Administrator or Administrative Hearing Panel. If sanctions are not completed by the due date—whether due to refusal, neglect, or any other reason—additional sanctions may be imposed, including suspension from HBKU. If needed, students can apply for an extension of the deadline. Extensions are at the discretion of the Student Conduct Administrator. A suspension from the university will only be lifted once all conduct sanctions are fully completed.

#### **Sanctions**

HBKU reserves the right, through fair process, to impose disciplinary and academic sanctions on students who have violated the Student Code of Conduct. Any sanction described below may be placed on deferred status. The list below is not exhaustive.

#### **Campus Housing Probation**

An official notice that the student's conduct is in violation of residence hall rules, QF Housing rules, and/or university rules and that more stringent student conduct sanctions, including removal from housing, may result if future violations occur.

#### **Community/University Service**

A student may be offered an opportunity to complete a specified number of hours of community/ university service in lieu of or in addition to other sanctions.

#### **Conduct Probation**

An official warning that the student's conduct is in violation of the HBKU Student Code of Conduct, but is not sufficiently serious to warrant expulsion, dismissal, or suspension. A student on conduct probation is "not in good disciplinary standing" with HBKU.

#### **Conduct Review**

An official warning that the student's conduct is in violation of the HBKU Student Code of Conduct, but is not sufficiently serious to warrant expulsion, dismissal, suspension, or conduct probation. A student on conduct review shall have their conduct under review for a specified period of time. This sanction may require regular meetings with an appropriate official to ascertain and evaluate compliance with the Student Code of Conduct. Additional restrictions or conditions may also be imposed depending on the nature and seriousness of the misconduct. Students placed on this sanction remain "in good disciplinary standing" with the university. If there is a finding of responsibility for subsequent violations of the Student Code of Conduct during this period of time, more severe sanctions may be administered.

#### **Criminal Trespass Warning**

In addition to being suspended or expelled from the university, the student is prohibited from entering the grounds and/or facilities owned, operated, and/or maintained by the university. Entrance onto campus or into those facilities/areas will be viewed as a violation of this sanction, and the student will be confronted and charged accordingly for trespassing and failure to comply.

#### **Deferred Loss of Campus Housing Privilege**

The sanction of Loss of Campus Housing Privilege may be placed in deferred status. If a student is found in violation of the Student Code of Conduct during the time of the deferred sanction, removal from housing takes effect immediately without further review. Additional student conduct sanctions appropriate to the new violation may also be taken.

#### **Deferred Suspension**

The sanction of Deferred Suspension may be placed in deferred status. If the student is found in violation of any university rule during the time of Deferred Suspension, the Suspension takes effect immediately without further review. Additional student conduct sanctions appropriate to the new violation may also be taken. A student who has been issued a Deferred Suspension sanction is deemed "not in good disciplinary standing" with the university.

#### **Dismissal**

Separation of the student from the university for an indefinite period of time. Readmission to the university may be possible in the future, but no specific time for a decision is established. In civil rights-related matters, respondents will have an opportunity to challenge the decision immediately following the removal.

#### **Educational Requirements**

A provision to complete a specific educational requirement directly related to the violation committed. Such educational requirements may include, but are not limited to, completion of an alcohol education workshop, an awareness workshop, essays, reports, or other education requirements, as deemed appropriate to support student development.

#### **Expulsion**

Permanent separation of the student from the university, whereby the student is not eligible for readmission.

#### **Letter of Enrollment Block**

A letter stating that the student may not enroll at HBKU without prior approval through the Vice President of Student Affairs (or their designee) if enrollment has been blocked for a previous student conduct problem or for medical reasons.

#### **Letter of Reprimand**

A letter providing a record of an incident that reflects unfavorably on the student or the university.

#### **Loss of Campus Housing Privilege**

Removal from university housing for disciplinary reasons.

#### **No Contact Order**

A no-contact order is a directive to prohibit intentional contact, whether direct or indirect, with one or more designated persons or group(s) through any means, including personal contact, email, telephone, social media, or third parties. A violation of a no-contact order can result in additional conduct charges, more severe consequences, and/or issuing a trespass warning.

#### **Restitution**

A payment for financial injury caused to another through misconduct. Restitution may be imposed alone or in addition to other sanctions.

#### Restrictions

The withdrawal of specified privileges for a definite period of time.

#### **Suspension**

Separation of the student from the university for a definite period of time. The student is not guaranteed readmission at the end of such a period of time, but is guaranteed a review of the case and a decision regarding eligibility for readmission.

#### **Warning**

Admonition of a student for actions unbecoming to the university community.

#### **Notifications and Disclaimers**

#### **Disciplinary Hold**

A hold will be placed on a student's university record while one or more of the following are pending: student conduct proceedings, expulsion, dismissal, separation, suspension, criminal trespass, deferred suspension, conduct probation, Honor Code review, conduct review, interim suspension, or other outstanding sanctions. The hold is placed on student data systems, including Banner. This hold will prevent the student from: 1) registering for future terms; 2) participating in drop/add; 3) receiving an academic transcript; and 4) receiving a diploma. A hold may be waived upon student written request.

#### **Handbook Subject to Change**

The provisions are subject to change without notice as deemed necessary and appropriate by the university administration.

### Standing with HBKU due to Disciplinary Reasons

A student who is not in good disciplinary standing with HBKU is subject to the following restrictions:

- Ineligibility to hold an office in any student organization recognized by HBKU or to hold any elected or appointed position within the university.
- Ineligibility to compete in intercollegiate athletic activity.
- Ineligibility to represent the university in any capacity, including representing the university at any official function.
- Ineligibility to receive a university-administered scholarship, fellowship, or grant when the sanction is in place for longer than one semester.

## **Student Emergency & Risk Management**

HBKU is committed to maintaining the safety, security, and well-being of all students. The following information outlines important procedures and resources to help you respond effectively in case of emergency.

## **HBKU Emergency Number**

#### **Emergency Procedures**

In the event of an emergency, follow the established procedures below:

#### **Evacuation**

- Follow exit signs and emergency personnel instructions.
- Do not use elevators.
- Gather at designated assembly points.

#### **Medical Emergency**

- ▶ Call the HBKU Emergency Line or 999.
- Provide the location and nature of the emergency.
- > Stay with the individual (if safe) until help arrives.

#### **Fire**

- Activate the nearest fire alarm.
- Evacuate immediately.
- Notify security of the location and type of fire.

#### **Suspicious Activity or Threat**

- Report immediately to the HBKU Emergency Line.
- Do not approach or engage with the suspicious individual or object.
- Follow security instructions.

## **Registering with Your Embassy in Qatar**

All international students are strongly encouraged to register with their embassy or consulate in Qatar. Registration allows embassies to:

- Contact you during emergencies or political unrest.
- Provide assistance in case of passport or legal issues.
- Notify your family in case of an emergency.

Embassy registration is usually available online through your home country's foreign affairs or consular services website.

It is also recommended to keep a copy of your passport, visa, and residency permit in a secure but accessible location.

Students can register for courses and make changes through Banner or through the Registrar's Office by submitting the appropriate forms. The registration dates, add/drop dates, and withdrawal dates are published on the HBKU academic calendar.

All students must seek their academic advisor's or program coordinator's input and assistance in the selection of courses. The academic advisor and program coordinator assist students in planning and scheduling courses that meet each student's degree plan and educational aims and in monitoring students' progress toward their degree objectives. Students must meet with their academic advisor every semester before registration and at least once during each academic year to evaluate progress toward their degree.

Forms to change registration are available through Banner.

#### **Requesting Official Documents**

The Registrar's Office provides students with official documentation related to their enrollment and status at the university. To request any official documents from the Registrar's Office, students should use the following links:

## **Important Things to Remember**

As students navigate through college life, they need to know and understand the academic policies that govern their studies. These policies are set in place to guide them through the academic functioning of HBKU.

The policies are published in detail online (https://www.hbku.edu.qa/en/academic-policies), but below are some important points students must be aware of:

#### **Academic Load**

This establishes minimum and maximum permissible academic load limits and their effect on graduate scholarship.

#### **Undergraduate Students Load**

- ▶ The minimum load for a full-time undergraduate student is 12 credit hours in a regular semester.
- Students enrolled in fewer credit hours than those required for a full-time designation are classified as part-time.
- The maximum load for an undergraduate student is typically 18 hours in a regular semester and 9 credit hours in the summer semester. The college's dean, based on the endorsement of the academic advisor, may permit students with a CGPA of 3.0 or higher to register for an overload.
- Any student who, due to extenuating circumstances, needs to drop below the minimum course load allowed will require approval in writing from the college's dean.

#### **Graduate Students Load**

- ▶ The full-time load for graduate students in a regular academic semester is 9 credit hours.
- Doctoral degree (PhD) programs at HBKU require full-time enrollment. Doctoral students not meeting the full-time load requirement may withdraw from a semester.
- A graduate student is permitted to enroll in a maximum load of 12 credit hours per semester. The maximum course load for graduate students during the summer is six credit hours.
- A graduate student on academic probation is permitted to carry a maximum load of 6 credit hours and will be considered full-time.
- For graduate scholarships, students are considered full-time if they enroll for nine graduate credit hours per semester or 18 credit hours per academic year.

#### **Adding and Dropping Courses**

Students shall register for courses during the period announced by the registrar in the official academic calendar. Students may change their academic course schedule as advertised in the academic calendar. A student must maintain full-time status unless granted special permission in writing by the academic advisor and the dean of the college.

## **Attendance Policy**

Attendance records start on the first day of class and end by the last week of class. All students are expected to attend all classes. Students are responsible for notifying the instructor ahead of time, when possible, of absences that might be excused by the instructor, such as in the case of a severe medical condition, a family emergency, or other authorized university activities.

Students exceeding the absence limit will receive a failing (F) grade in the respective course. :

#### **Undergraduate Attendance Policy**

- ▶ Attendance on the first d y of classes is mandatory for all registered courses.
- > Students who do not attend the first class of a course may be removed from the course.
- A student should not miss more than 15% of classes during a semester without a documented excuse.
- A student should not miss more than 25% of classes during a semester with prior permission from the instructor or with a documented excuse.
- Students exceeding the excused absence limit may be allowed to withdraw from the semester with the approval of the dean. These students will not be exempt from the late withdrawal fees.

#### **Graduate Attendance Policy**

- ▶ The instructor must establish the attendance policy for each respective graduate course.
- ▶ The instructor's attendance policy must be specified in the course syllabus and must be communicated in the first class meeting of the semester.
- Students exceeding the excused absence limit may be allowed to withdraw from the semester with the dean's approval. These students will not be exempt from the late withdrawal fees.

## **Grade Appeal Process**

#### To challenge a grade for an academic course, students must:

- Contact the course instructor. If the instructor concurs with the student's claims, they will submit a grade change request to the dean. In turn, the dean will submit the grade change to the registrar. The registrar will notify the student of the change.
- If a resolution cannot be reached with the course instructor, the student may appeal to the respective college dean. The appeal form should be submitted electronically through Banner.
- The appeal petition must be submitted to the dean within 30 days from the end of the semester in which the grade was recorded. Whether or not the student has graduated has no bearing.
- If the student is not satisfied with the dea 's decision, they can appeal to the provost, who shall have the final decision on the matter. The provost may form an ad hoc committee to review and recommend a decision.

## **Withdrawal Policy**

#### **Leave of Absence**

Students may request to suspend their studies for a justifiable eason within the add and drop period. Students with approved leave periods are classified as "active" students.

#### Withdrawal from a course

- After the add/drop deadline, students may withdraw from a course before the final deadline o withdraw from courses as indicated in the university's academic calendar.
- A grade of "W" shall be assigned and will appear on the transcript for courses from which the student has withdrawn within the announced withdrawal period.
- ▶ The student must still maintain a full-time status unless the dean of their respective college grants special approval in writing.
- Students who stop attending classes and have not formally applied to withdraw from the course(s) shall receive an "F" grade for the course(s).

#### Withdrawal from a semester

- A student who seeks to withdraw from a semester must secure the college's dean's approval. Students who stop attending classes without formal approval to withdraw from a semester will be assigned a grade of "F" for all courses, which could establish grounds to dismiss a student academically.
- ▶ Withdrawal from a semester disqualifies a student f om scholarships or financial aid.
- > Students must register in the following regular semester.
- > Students may be academically dismissed if they extend their leave beyond the approved period.
- The request form to withdraw from the semester is available electronically through Banner.

#### Withdrawal from the university

- A student who seeks to withdraw from the university with the intention to return must secure the college dean's approval. Failure to secure the college dean's approval may result in academic dismissal.
- > Students who withdraw from the university are not qualified o maintain scholarships or financial aid

#### Holds

Administrative and/or academic holds may be imposed on students to prevent registration, graduation, application, etc., if administrative or academic requirements have not been fulfilled before the registration period. Administrative and academic holds may include, but are not limited to:

- Outstanding financial due
- Incomplete admission requirements
- Failure to process readmission papers on time
- Failure to meet college and program-specific equirements
- Academic dismissal
- Academic advising

All undergraduate students will have a registration hold placed on their records, which will only be cleared once they have met with their academic advisor.

## **Student Registration Policy**

## **Non-Degree Students**

All academic policies that govern regular students apply to non-degree students, except in certain cases mentioned in the policy. Visiting students must submit the required documents mentioned in the policy.

## **Repeated Courses**

Students, under certain circumstances, as articulated in the course repeat policy, may be permitted to repeat a previously completed course.

#### **Transfer Credit**

Credits earned at a recognized educational institution prior to admission to an HBKU program may be eligible to be transferred. Details of eligibility are available in the academic policies online.

## **Degree Requirements**

#### **Undergraduate Students**

#### **Graduate Students**

Students must complete all program requirements as outlined in the study plan and respective catalogue to earn their degree. Grades lower than a "B" are normally considered an unacceptable measure of progress toward graduate degree objectives. A grade of "C+" is considered the minimum passing grade for a graduate course. A grade under "C+" shall be reported as an "F". No graduate student can graduate with a CGPA below 3.0. Academic advisors should take immediate remedial action for students whose CGPA has dropped below 3.0. For a complete list of graduate degree requirements: CLICK HERE

#### Accreditation

All the programs at HBKU have been recognized by the Ministry of Education and Higher Education in Qatar. Most recently, the College of Science and Engineering received accreditation from the Engineering Accreditation Commission (EAC) of ABET for its Bachelor of Science in Computer Engineering.

Students can request an educational certificate equivalency of their official documents from the <u>Ministry of Education and Higher Education</u> (Certificates Equivalency Section), the Equivalence Office, and they can also document them at the <u>Ministry of Foreign Affairs</u>.

The Bachelor of Science program in Computer Engineering is accredited by the Engineering Accreditation Commission (EAC) of ABET. www.abet.org.

All courses attempted are recorded on the transcript and used in the CGPA calculation. CGPA is computed by dividing the total grade points by the attempted hours. AU, TC, and W grades are not included in the CGPA calculation.

## **Academic Standing**

The academic progress status of a student, which indicates accumulated academic performance, can be one of three academic standings: Good Standing, Probation, or Academic Dismissal. The Office of the Registrar evaluates the academic standing at the end of the regular semesters (Fall and Spring). The academic standing results for the summer will be reported in the fall semester evaluation.

#### **Academic Honor**

Undergraduate students may qualify to graduate Summa Cum Laude by holding a final g ade point average of 3.90 or above, Magna Cum Laude by holding a final g ade point average of 3.70 - 3.89, and Cum Laude by holding a final g ade point average of 3.50 - 3.69.

#### **Dean's List**

An annual published record of undergraduate students who achieve a CGPA of 3.5 or higher in the academic year preceding the annuancement of the list.

#### **President's List**

UAn annual published record of undergraduate students who achieve a CGPA of 3.75 or higher in the academic year preceding the announcement of the list.

## **HBKU Academic Honesty and Code of Honor**

The academic honor code is a set of statements articulating ideals and ethical principles that students, faculty, and staff must adhere to create an atmosphere of trust and respect within the academic community. The honor code includes a set of rules addressing issues related to cheating, fabrication, falsification of results, plagiarism, collusion, misrepresentation, etc. Students at HBKU must be responsible for making themselves aware of and following the university's policies and regulations.

Students are responsible for their conduct and are expected to adhere to a high level of integrity and responsibility. Student behavior and conduct must be driven by honesty, integrity, and the highest ethical standards. Students must follow all academic regulations governing student behavior on campus and campus-sponsored housing. When a violation of the Code of Honor occurs, it will be handled in a manner that would educate the student to be a responsible member of the community and guide them to develop high personal ethical responsibility. A fair process is established in which an appeal can be requested. The appeals process aims to achieve fairness and unbiased decisions. Students' academic integrity and good behavioral conduct are essential to a positive learning environment and are crucial to our educational endeavors. Students, faculty, and staff are expected to follow the code of academic behavior outlined in the following sections.

## **Academic Malpractices and Misconduct**

#### **Plagiarism**

As the MLA Handbook states, plagiarism is "using another person's ideas, information, or expressions without acknowledging that person's work." It does not matter whether a student does this intentionally or unintentionally; it is always "intellectual theft."

#### Cheating

Cheating is a general type of malpractice whereby a student engages in dishonest action in completing the work of a course.

#### Collusion

Collusion is any attempt to conceal other students' work or input to a collaborative assignment or allow others to copy their work and submit it as their own.

#### **Fabrication or Falsification of Results**

Fabrication is the intentional act of making up results or data and reporting them. Falsification is the intentional act of manipulating research materials, data, equipment, or processes. It also involves intentionally changing or omitting/suppressing data or results without clarification and scientific or statistical justification

#### Other Areas of Malpractice or Violation of Honor Standards

These include abuse/threatening behavior, computer security violations, intellectual property violation, criminal violation on campus, other university properties or at any university activity, disciplinary sanctions violations, disorderly conduct on university property, failure to comply with instructions, providing false information, tampering with fi e equipment, forging, fraudulent business dealings on campus or elsewhere, illegal substances, disruption of authorized activities on campus, policy violations, solicitation, theft, unauthorized entry or use, sexual harassment, possession of weapons.

## **Academic Disciplinary Actions and Procedure**

Academic disciplinary actions are the penalties or sanctions imposed for violation of academic regulations, including plagiarism, academic malpractice, violation of honor standards defined in the previous sections, or other behavior judged as inappropriate academic conduct. It should be noted that there shall be no statute of limitations that impedes faculty from taking action upon the discovery of such violations by a student.

#### **Jurisdiction**

Violations involving academic misconduct are within the jurisdiction of faculty members, program coordinators, the dean of the college, and the provost. All violation cases must be transferred to the office of the provost for recording and for determining appropriate action in consultation with the disciplinary committee and/or other parties as appropriate to the violation case.

#### **Disciplinary Action Procedure for Academic Misconduct**

The violation of academic regulations shall be considered confidential. The following procedure shall be followed when a faculty member reasonably suspects that a student under the faculty member's supervision has violated the Code of Honor.

#### **Disciplinary Action Procedure for Non-Academic Misconduct**

Members of the HBKU community may file a cha ge of misconduct against a student with the college dean or the office of the ovost within three days of the occurrence of the incident. Students will be notified of the alleged cha ges so they can prepare a response. The dean or the provost shall determine if the Code of Honor has been violated and if the alleged charge is to be investigated by the disciplinary committee.

#### **Possible Penalties and Disciplinary Actions**

The disciplinary actions taken for cases of academic malpractice will vary depending on the nature of the case and the student's standing.

#### **Disciplinary Committee**

The role of the Disciplinary Committee is to conduct reviews of the academic and non-academic disciplinary actions and appeals, as well as final g ade reviews and appeals, and to conduct hearing sessions in case of academic dishonesty appeals and disputes. <u>Code of Honor</u>
